
The vehicle's keys have built-in transponder chips that prevent the engine from starting if the key has not been previously registered in the vehicle's on-board computer.

Never leave the keys inside the vehicle when you leave the vehicle.



Vehicles with smart key system: The indicator light flashes after the "ENGINE START STOP" switch has been turned off to indicate that the system is operating.

Vehicles without smart key system: The indicator light flashes after the key has been removed from the engine switch to indicate that the system is operating.

n System maintenance

The vehicle has a maintenance-free type of engine immobilizer system.

${\rm n}\,$ Conditions that may cause the system to malfunction

- 1 If the key is in contact with a metallic object.
- 1 If the key is in close proximity to or touching a key to the security system (key with a built-in transponder chip) of another vehicle.

n For proper system operation


Do not modify, remove or disable the engine immobilizer system. If any unauthorized changes or modifications are made, the proper operation of the system cannot be guaranteed. The system sounds the alarm and flashes lights when forcible entry is detected.

n Triggering of the alarm

The alarm is triggered in the following situations.

- 1 A locked door is unlocked or opened in any way other than by using the entry function (vehicles with smart key system), the wireless remote control door lock function or the mechanical key. (The doors will lock again automatically.)
- 1 The hood is opened while the vehicle is locked.
- 1 The battery is reconnected.
- 1 The side windows are tapped or broken.

n Setting the alarm system



Close the doors and hood, and lock all doors using the entry function (vehicles with smart key system) or the wireless remote control door lock function. The system will be set automatically after 30 seconds.

The indicator light changes from being on to flashing when the system is set.

n Deactivating or stopping the alarm

Do one of the following to deactivate or stop the alarm.

- 1 Unlock the doors using the entry function (vehicles with smart key system) or the wireless remote control.
- 1 Start the engine. (The alarm will be deactivated or stopped after a few seconds.)

${\rm n\,}$ ltems to check before locking the vehicle

To prevent unexpected triggering of the alarm and vehicle theft, make sure of the following.

- 1 Nobody is in the vehicle.
- 1 The windows and moon roof are closed before the alarm is set.
- 1 No valuables or other personal items are left in the vehicle.

n Triggering of the alarm

The alarm may be triggered in the following situations. (Stopping the alarm deactivates the alarm system.)

- 1 A person inside the vehicle opens a door or hood.
- 1 The battery is recharged or replaced when the vehicle is locked.

n Panic mode

Vehicles with smart key system



When (() is pressed for longer than about one second, an alarm will sound for about 60 seconds and the vehicle lights will flash or come on to deter any person from trying to break into or damage your vehicle.

To stop the alarm, press any button on the wireless remote control.



1-6. Theft deterrent system Theft prevention labels (U.S.A.)



These labels are attached to the vehicle to reduce vehicle theft by facilitating the tracing and recovery of parts from stolen vehicles. Do not remove under penalty of law.
